



However, teachers belonging to Scheduled Tribes should not be admitted without submitting a caste verification certificate as per the provisions of Government Decision No. STC-1099/Proc./14/Ka/Mumbai-32, dated 16-08-2000. If necessary, the time limit for admission of these teachers should be extended.
- 6. Deprived Tribes (A), Nomadic Tribes (B), Nomadic Tribes (D), Other Backward Classes and Special Backward Classes should not be admitted without submitting a caste verification certificate stating that they do not fall into the advanced and advanced groups (non-Crimelier).
